Future format of the ISSAIs			
Future format of the ISSAIs	To build a shared understanding of the format of the ISSAIs	Under the new SDP the ambition of the I-initiative is to revise the ISSAIs. This work builds on the work already done in Component 1. The drafting work under the I-initiative is to be carried out by project groups. FIPP will be responsible for providing guidance to the project groups during their work. During 2024 FIPP will consequently spend some time discussing the format of the ISSAIs.  As part of this process, an assignment was sent to the FIPP members as homework before the meeting. The exercise involved considering the logical relationship and linkages between the auditing principles, requirements and application material within the ISSAIs, looking at ISSAI 100, 400 and 4000.  The purpose was to build a shared understanding of the format of the ISSAIs so that FIPP will be prepared for future discussions related to initiatives and projects in the new SDP.  Several issues were identified from the discussion on the assignment, including gaps in definitions and use of concepts, lack of consistency between principles related to the audit process and general principles, high degree of repetitions from ISSAI 100 in the subordinate documents etc. The exercise also showed the importance of coordination between the initiatives and that updates in documents should be presented across the framework.	



		Pronouncements		
		It was concluded that this is an important exercise to do for those who are going to be part of these projects. It is only when one is doing the comparisons hands-on that the shortcomings become evident.		
		The main message is that there are weaknesses in today's structure, but they are solvable. Also, that changes might influence the way we do audit, regardless of how SAIs refer to the ISSAIs – therefore criteria need to be operationalized for what can be considered "not changing the way we do audit".

A discussion on possible format for an updated SDP project proposal template	To discuss and agree on possible elements to include in an SDP Project proposal template	An assignment was sent out in advance as homework, on possible elements to include in an SDP Project proposal template. The discussion is postponed to the next FIPP meeting, 18 June.  Based on the feedback received from FIPP members, the FIPP secretariat will develop a paper for discussion regarding important issues and level of detail in a Project proposal template.
